Please see the checklist below for instructions on how to submit a zoning certification request. **Documents must be mailed or hand-delivered, payment online is not available**. Upon receiving your request, a letter will be emailed to the requestor in ten (10) business days.

# Auto Broker/Auto Dealer Submittal Requirements

### 1A. A letter that requests official certification of a property's zoning classification. The letter must include:

- the requestor's contact information (email address, phone number, etc.)
- to whom the letter should be addressed to
- · address of the subject property and
- the full parcel identification number of the subject property (also known as the tax ID number, which can
  be obtained from the DeKalb County Tax Commissioner's website; go to
  <a href="https://dklbweb.dekalbga.org/taxcommissioner/index.asp">https://dklbweb.dekalbga.org/taxcommissioner/index.asp</a> then click on Property Tax.
- Current rental agreement or proof of ownership of property.

# Zoning Certification Submittal Requirements

#### 1B. A letter that requests official certification of a property's zoning classification. The letter must include:

- the requestor's contact information,
- to whom the letter should be addressed to,
- the address of the subject property, and
- the full parcel identification number of the subject property (also known as the tax ID number, which can be obtained from the DeKalb County Tax Commissioner's website; go to <a href="https://dklbweb.dekalbga.org/taxcommissioner/index.asp">https://dklbweb.dekalbga.org/taxcommissioner/index.asp</a> then click on Property Tax
- Survey and Legal Description; on 8½ x 11 paper = PLEASE DO NOT SEND OVERSIZED PAPER
- 2. \$30.00 (check or money order) payment for each address request made out to "**DeKalb County**"; request can be sent by **mail** or **hand delivered**:
