Dear Resident/Homeowner,

As part of DeKalb County’s \$2.4 billion capital improvement program, the Department of Watershed Management (DWM) will be improving the capacity and service of the Watershed systems serving your community. The **Scott Boulevard Phase III Water Main Replacement Project** has been designed to improve the watershed system in your community.

This letter serves as notification that construction related to this project will require a single lane closure of **Brown Place** between **East College Avenue** and **Craigie Avenue** beginning **Nov. 1** for approximately three weeks. Normal construction hours will be from 8 a.m. to 5 p.m.

Motorists should expect delays stemming from the road closure. Precautionary signs and traffic flaggers will assist in moving safely through the lane closure. Our construction crews will work persistently to minimize the length of impact to residents and motorists.

Dear Resident/Homeowner,

As part of DeKalb County’s \$2.4 billion capital improvement program, the Department of Watershed Management (DWM) will be improving the capacity and service of the Watershed systems serving your community. The **Scott Boulevard Water Main Replacement Project Phase III** has been designed to improve the watershed system in your community.

This letter serves as notification that construction related to this project will require three partial lane closures beginning **Nov. 21** for approximately nine weeks. Normal construction hours will be from 8 a.m. to 5 p.m. The single lane closures consist of the following details:

- A single lane closure of **Russell Drive** between **Chester Way** and **South Columbia Drive**
- A single lane closure of **South Columbia Drive** between **North Carter Drive** and **Walker Drive**
- A partial single lane closure of **Carter Road** between **South Columbia Drive** and **Midway Road**

Motorists should expect delays stemming from the lane closures. Precautionary signs and traffic flaggers will assist in moving safely through the lane closures. Our construction crews will work persistently to minimize the length of impact to residents and motorists.
