As part of DeKalb County's \$4.27 billion capital improvement program, the Department of Watershed Management (DWM) will be improving the capacity and service of the Watershed systems serving your community. The **Peachtree Boulevard Water Transmission Main Replacement Project** has been designed to improve the watershed system in your community.

This letter serves as formal notification that on **Friday, July 31**, the intersection of **Peachtree Boulevard** and **Chamblee Dunwoody Road** will be affected by intermittent lane closures between 9 a.m. and 4 p.m., barring any weather delays. Northbound travelers on Peachtree Boulevard will need to detour to American Way instead of turning right on Chamblee Dunwoody Road because the right turn lane will be closed. Westbound travelers on Chamblee Dunwoody Road will be directed around the lane closure and through the intersection to Peachtree Boulevard.

Normal construction hours will be from 9 a.m. to 4 p.m., Monday through Friday, excluding major holidays. An increase in construction-related noise and traffic during work hours should be expected. Precautionary signs, traffic flaggers and law enforcement will assist in moving safely around the closed off portion of the road.

Ruby-Collins, working on behalf of DeKalb County, is the authorized contractor for the **Peachtree Boulevard Water Transmission Main Replacement Project**. All workers will be wearing proper identification and driving marked vehicles.
