STAFF RECOMMENDATION: APPROVAL.

The property owner of 4444 Davana Drive, Barbara Moore (wife of the late Mr. James Moore in Ellenwood), is assisted by Sharon Levister in the requested street name change of the Right-of-Way (ROW) designated as Davana Drive to James Moore Drive. The street begins at its intersection with Linecrest Road and continues south past its intersection with Oscar Road, where it terminates with no further access. The ROW is classified as a local street.

The renaming would honor Ms. Moore’s late husband, who was instrumental in the community with a record of many successful initiatives, including a fire station, Ellenwood library, Marta bus stops, and the improvement/paving of Davana Drive from what was once a dirt road.

The property owner and community have submitted the proper documentation via petitions meeting the required 51% in support. Seven (7) of ten (10) property owners (70%) signed the petition in support of the street renaming.

Adverse impacts are expected to be minimal aside from an administrative burden, as property owners must update addresses on business and personal items.

Staff recommends “*Approval*”.

Dear Dekalb County Commissioners,

We, the undersigned residents of the County Line Community and surrounding areas, respectfully petition the renaming of **Davana Drive to James Moore Drive** in honor of Mr. James Moore, a lifelong community leader, activist, and dedicated public servant whose tireless efforts transformed and improved our community for generations.

Mr. James Moore was one of the original grassroots leaders of the County Line Community, known for his unwavering commitment to family, faith, and civic responsibility. For close to 70 years he lived on Davana Drive and for more than 30 years, he worked diligently to advocate for residents, improve infrastructure, and secure essential resources for the Ellenwood and South DeKalb communities.

Among his many accomplishments, Mr. Moore was instrumental in spearheading the effort to have Davana Drive and surrounding community roads paved. At a time when many roads in the County Line Community remained dirt roads, Mr. Moore organized residents, gathered petitions, attended county meetings, and tirelessly advocated for infrastructure improvements that would provide safer and more reliable transportation for homeowners and families. The paving of Davana Drive stands today as a visible and lasting reminder of his dedication, persistence, and leadership.

Mr. Moore also helped organize the first County Line Community Civic Association in the late 1970's, serving for many years as President and later as Treasurer. His advocacy contributed to numerous community improvements, including:

- Installation of streetlights and improved neighborhood infrastructure
- Expansion of MARTA transit service into the Ellenwood area
- Development of local parks and recreational planning
- Advocacy for police accountability and the establishment of a local police substation
- Support for the construction of a local fire station to improve emergency response times
- Support for the development of the Ellenwood/River Road Library
- Environmental advocacy efforts to address landfill operations affecting the community

Mr. Moore was known for walking door-to-door collecting signatures, attending commissioner meetings in Decatur, speaking at county meetings, and ensuring the voices of homeowners and residents were heard. His leadership, dedication, and service left a permanent impact on the County Line Community.

Renaming Davana Drive to **James Moore Drive** would be a fitting and meaningful tribute to a man whose hard work helped shape the very road and community we benefit from today. This honor would preserve his legacy and inspire future generations to continue serving their community with the same commitment and integrity.

We respectfully request approval of this petition to rename Davana Drive in recognition of the extraordinary contributions and lasting legacy of Mr. James Moore.

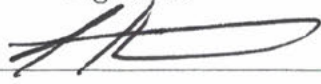
