ATTACHMENT A

SCOPE OF WORK

INTRODUCTION:

DeKalb County Sanitation is seeking for qualified vendor in retrieving 2,340 **green** garbage roll carts and 2,340 **blue** recycle roll carts from the City of Doraville. This is a one-time service.

MINIMUM SPECIFICATIONS:

The garbage and recycle roll carts retrieval service will include but not limited to the following:

- Retrieval of green garbage roll carts and blue recycling roll carts from 3 collection routes within the City of Doraville. Note: Each collection route consists of a list of streets for service.
- Work must begin and complete within one designated day: Thursday, May 29, 2025, from 7AM until finish. Note: In the event the weather does not permit for service, a different service date will be decided by DeKalb Sanitation.
- Prior to the beginning of the project, the Contractor is required to attend an inperson meeting with the DeKalb Sanitation team for the kickoff of the project.
- Contractor provides all trucks, equipment, tools, labor, and all necessary to complete the task.
- Contractor must provide an onsite Supervisor for the crews.
- A minimum of 2 trucks and 2 crews of 4 persons (1 driver/supervisor and 3 crews) per each route is recommended.
- Contractor will come behind the Sanitation's service truck and retrieve the emptied roll carts from curb sides, remove the wheels and axles from each roll cart, then stack the roll carts on Contractor provided truck, sorted by color.
- All retrieved garbage and recycle roll carts will be transported to the final destination, the Seminole Road Landfill, 4203 Clevemont Rd., Ellenwood, GA.
 Note: For time efficiency, Contractor may transport, and unload retrieved roll carts at the North Collection Lot, located at 2315 Chamblee-Tucker Road, Chamblee, GA. However, after completion of the project, and within 24 hours,

- the Contractor must remove and transfer all retrieved roll carts from the North Collection Lot to the Seminole Road Landfill, the final destination.
- Contractor must keep track of all streets that are serviced using an Excel spreadsheet and provide to the DeKalb Sanitation at the end of the project.
- Bidder must include in the Price Schedule, the number trucks, supervisor, and crews that will be assigned for this project.

MINIMUM QUALIFICATIONS:

- The Contractor must have a minimum of 2-year of experience on handling garbage/recycle roll carts;
- Must demonstrate completion of at least 2 roll cart projects;
- Must provide a minimum of 3 references for projects similar in size and scope as
 proof of experience. <u>Note:</u> Each reference must include project name and
 location, project description, and the reference contact information. The
 ineffectiveness of contact information and/or the reference's lack of
 responsiveness may result in being deemed non-responsible.
- Bidder who does not meet the above stated minimum qualifications will be deemed non-responsive and will be disqualified from this project.
