She stated as a Moorish and as a national, she has rights to the property secured by the Constitution for the United States of America.

She stated that she has been at this property for 40 years and has been fighting with the DeKalb County Tax Commissioner's office since 2017. She is requesting that these notices no longer be sent to her location which is: 1926 Cannon Street. She also stated that in the future if she receives these notices she will have to take legal action. She passed her documents around the table for all to review. The Chair asked for questions or comments from the table. Calvin Hicks stated that we will receive the documents and will have the law department review them and make a recommendation to the Board. She also gave other documents to Calvin Hicks as directed by the Tax Commissioner's office. He received them and thanked her. The Chair thanked her for coming.

The Chair called for a discussion of Staff Recommendations for batches 1 through 28.
