Hold Harmless Agreement for Commercial Container Request

Hereinafter "Lessee") does hereby agree, in exchange for the lease of any commercial container(s), ereinafter "Equipment" provided by the Sanitation Division, hereinafter "County" and for other alid consideration, to indemnify and hold harmless the County, its agents, servants and employees om all claims and liability which may be made against the County for the County's rental of the quipment to lessee. During the rental period, said equipment shall be located at the following ddress:
he addressee above willingly and knowingly assumes any and all risk, and known accidents, nyway associated with the rental and use of the equipment.
a accordance with the terms of this agreement, the lessee shall immediately report any accident aims or damage related in any way to the rental or use of the equipment to the County, and eliver to the County by certified mail to - the DeKalb County Sanitation Division, 3720 Leroy Scott rive, Decatur, GA 30032, ATT: Division Director - a copy of all processes, pleading notices or apers of any kind received by the lessee or any other operator or agent of the lessee relating to any aim, suit or proceeding connected with any accident or event involving the equipment.
essee hereby agrees to RELEASE , INDEMNIFY AND HOLD HARMLESS , to the fullest extent ermissible by law, the County, its officials, officers, employees and agents, from any and all losses, abilities, damages, injuries, claims, cost and expenses of every character whatsoever, including ithout limitation: (1). Demands arising from injuries or death of persons, including officials, ficers, employees and agents of lessee or County; (2). Claims or liabilities to third parties arising at of the abandonment, conversion, secretion, concealment, or unauthorized sale of the equipment of the lessee or its operator, agents or employees, or the confiscation of the equipment by any evernment authority for illegal or improper use of said equipment; and (3). Damage to property rising directly or indirectly from the obligation herein undertaken, or out of, or connected with the assession, maintenance or use of the equipment. The provision of the indemnity described herein hall apply regardless of whether the lessee's negligence, active or passive, contributed in any way alleged injury or harm, and shall not be limited.
