#### 2025 Medicare Retiree Health Renewals

-Question MLS: this would be a 7% increase? The cost impact would be over \$7 million? So this would be up over \$500,000 from when it was last approved?

#### Pension Board Re-Appointment Discussion

-re-appointment documents provided by Central Staff

-TT: I will introduce these 2 items on the next available agenda and we will plan to hear them in the ERPS committee at the next available opportunity; we will walk it on November 12th and have them in the ERPS Committee at the next opportunity -Commissioner Terry requests Central Staff reach out to the re-appointee candidates to invite them to the next ERPS for an interview

#### Commission on Accreditation for Law Enforcement Agencies (CALEA) Requirements Review

-presentation provided by Chief Ramos, Sgt. Tiffany Cribbs - accreditations manager -comments provided by Commissioner Davis Johnson -Question MLS: What is the annual fee for CALEA and the GCAP State certification? Is it a barrier to entry? I'm trying to understand why it's less than 6% of the State that are certified by both. -response provided by Sergeant Cribbs -Question TT: Could the Board of Commissioners and public review a copy of the CALEA reports? -response provided by Chief Ramos -Question TT: Are previous years of accreditation reports available? -Chief Ramos: I am not sure if those are available; we do not have access to the database for reports. Additional comments provided by Chief Ramos -Question TT: is it important for the policy makers and civilians that we serve to understand what CALEA means, the things we do right and share those things? -response provided by Chief Ramos regarding sharing information with the public after the next certification period in March -comments provided by Commissioner Terry regarding the importance of transparency and accountability -Question TT: How do the CALEA assessors determine who are the Community Faith Leaders? -Sgt. Cribbs: We reached out to people that we knew were involved in the community that we have interacted with in the department to participate in the civilian panels; additional comments provided by Sgt. Cribbs -Question TT: are those chosen on the panel a true representation of the community? -comments provided by Chief Ramos -Question MDJ: how long has CALEA been in existence? They are still an independent organization? -Sgt. Cribbs: since the 1980's, and ves ma'am -MDJ: I believe they would be the experts that know how to run this program -comments provided by Chief Ramos -Question TT: how do we see the portal results from a commissioner perspective? -Chief Ramos: no one but myself and the accreditations manager have access to the portal; CALEA determines who can review and when the reports are available -Question TT: what is the issue with having the CALEA report discussed in the ERPS Committee, perhaps on an annual basis? -Ramos: there is no problem with that; when the report is available we can share it -comments provided by Commissioner Long Spears -Question MLS: every 4 years an on-site assessment is conducted, when is that? -Sgt. Cribbs: we just had one 2 weeks ago -additional comments provided by Chief Ramos regarding the board's review process in March 2025 as a result of the on site assessment in October 2024 -Commissioner Long Spears suggested a special called ERPS meeting to discuss the latest CALEA report in 2025 once available -Question TT: have you all discussed having a citizen advisory board? -response provided by Chief Ramos regarding a review board that was previously formed in the past; additional information provided regarding town halls and community meetings organized by the Police Department -Commissioner Terry requests a copy of the report and a review of the recommendations or findings.
