TT: I'm not looking for action today, I'd request deferment to be able to review and meet one on one to go over any questions or concerns of the most recent draft.

Question MDJ: why deferral to ask a consultant to look into a need? Did central staff look into if the two boards here in Georgia were created proactively or reactively?

SM: I would need to connect with City of Atlanta to determined. but Athens-Clarke's was developed after an event that occurred during the pandemic that sparked the governing authority's interest in research and creation.

Question MDJ: my question still remains why defer it?

Question MLS: I am open to a deferral to review. My question is instead of diving into this we commit to a one time audit of police to determine if there are any findings that warrant a need for review board, however if not then we just conclude the item and move forward. I am concerned, based on conversations I've had it would disrupt moral in the police force.

Question RP: was there any conversations with other jurisdictions to see if there could be comparisons with other municipality forces in DeKalb County?

Ernstes: there have been no discussions. I would be difficult legally for the County to try and include the city's police departments. We can have those discussions but I do not think they would be fruitful.

Comments provided by Commissioner Patrick

Question MLS: I still have questions if we move forward, how would it be populated, how would staff and members be trained, what is the oversight specifically. I am in favor of deferral of the item to continue to review and have discussions.

TT: One point of coconscious sounds like we all have is taking stock of our current resources, Internal affairs does internal reviews. if the administration is willing to come back with a response on a one time audit of internal affairs over a certain period of time to determine if there are issues that would or could have benefited from a review board. I'm not sure on the details of how it would happen, if there is a specific process or something OIIA could do. My opinion I think we should be proactive and get ahead of anything that could happen in the future. MLS: I would like to hear Chief Ramos' opinion about doing a time framed audit and if we have had any flags in the past.

MDJ: I think that the GBI also has power to investigate officer involved incidences. Can director Lumpkin and speak to the investigation process. Second, I would prefer a consultant that does this time of work, that we could select to give recommendations than an auditor, especially one that is in the department that may or may not be familiar or know history or rules or regulations. I would like to see an agency rather than an audit give recommendations.

Lumpkin: GBI typically investigates criminal matters although it can investigate matters at the Governor's request. Typically they do not investigate administrative matters. Internal review boards across the country have different powers and structures and depending on those will spend its time accordingly.

Ouestion MLS: does GBI do audits; could we call them and ask them to come in and review cases?

Lumpkin: probably not. Additional Context provided.

Question RP: Are DeKalb County police CALEA certified?

Lumpkin: yes, we are state certified and CALEA accredited

Question RP: What do we have to be incompliance with to receive accreditation? Does it get into

administrative policies that a review board might as well?

Lumpkin: there are state policies and certifications you must satisfy on each investigation or behavioral performances. There are many more CALEA you have to adhere to.

Question RP: Do we know if the other two jurisdictions that have review boards, are they CALEA accredited?

Lumpkin: there is a list of state and CALEA certifications we can provided.

Question MLS: can you define the acronym CALEA for me?

Lumpkin: Commission on Accreditation for Law Enforcement Agencies

COO: I think having a conversation on what the process if on accreditation may be informative. It may well be if we can articulate what we currently do may broaden the perspective. I don't know if we've talked before about what are the safety and accountability measures that are currently in place that happen could be a good starting point

MLS: I agree

Question MDJ: what happens if you are not certified under CALEA?

Lumpkin: there's not requirements to state or nationally certified.

MDJ: since it is deferred 30 days; at the next ERPS meeting can we discuss what is covered under CALEA certification.

Question TT: if there is a wanted vehicle you can monitor in real time?

Ramos: if the vehicle is marked stolen and goes through your system it will notify detection.

Question MDJ: is there any cost sharing with municipalities?

Ramos: no, if they want to install cameras within their limits they taken on the cost burden. I will provide a list of locations for all cameras by district. I could not get that in time for this meeting.

Question RP: does Flock do active recording? Ramos: it gives up a snapshot it's not a live feed.
