#### III. DISCUSSION

Charter Review Recommendations

MDJ: We have former CEO Lee May with us today

Comments provided by former CEO Lee May

LM: Couple of denominators from the 2017 and 2023 charter review, three members. I want to highlight the importance of this ongoing work. I would ask the commissioners do look at the nuances of the requests,

MLS: I wanted to speak to the recommendation of Board's subpoena power. It was apart of the 2017 review as well. Can you expand on the recommendation

LM: I created the review commission I did not guide them. I think there could be dangerous in just having open subpoena power to the board. If there is support from this board I think more detail needs to be added. The broader it is the more danger it is. Additional context provided.

MLS: we are looking other counties with CEO Governments which boards do have that power- my team is looking at that now and we can bring it back.

LM: On the face of it I don't support subpoena power but I am open to the discussion

Comments provided by Commissioner Terry

TT: What you think about CEO form government version county manager form of government, what are the balance of powers that should exist? How do you see the CEO form of government coming together and prompting transparencies to review data and facts to get a coconscious.

LM: I always think it is healthy to have proactive discussions on our government. We need to look at how we service delivery, shift in capacity and demographics and other nuances. It makes sense to review other governments here in Georgia, Rockdale has a chairman form of government.

TT: regarding the CEO/COO the redline officers a name change. Structurally I think the CEO branch have more power and so if Section 9E doesn't get adopted I do believe there will still be an effort for commissioners to know what the recourse is when we want data or information and cannot get it.

MDJ: I don't believe the 2017 recommendation for subpoena power was a broad as this one. One of the questions is what is the limit and does it also extent to the other constitutionals, do we need a supermajority from the board? I still have questions regarding it.

Comments provided by Former CEO Lee May

Question MLS: recommendation about appointments. Section 15A and 15E covers those and expands on requirements for appointments. Many on the commission have supported a 'fill by' period.

TT: We need to figure out what appropriate for appointments, I think 60 days to fill it is appropriate.

MDJ: and what about when commissioners do not fill their appointees.

LM: a few things to close, my personal recommendation would always need to be 4 members to vote to approve. The CEOs ability to call a meeting, Section 13 F & G - maybe needs to be spelled out more. CEO managing all external relationship but what is the role of the board. The COO term if that needs to be limited or contractually based, it should be built into the charter. I will provide everything else in writing to the commission.
